KnowBC.com is available to BC's post-secondary institution libraries via site licence either by group subscription through the BC Electronic Library Network (contact Anita B. Cocchia, Executive Director, 778-782-7004 or anitac@eln.bc.ca) or by single subscription from Harbour Publishing Co. Ltd. The single site licence is offered for a term of one year, and may be renewed annually. The terms of the licence allow all students, faculty and staff of an individual post-secondary institution to access KnowBC.com, both from campus and from home.

TERMS AND CONDITIONS

1.0 Definitions

- 1.1 "Service" shall mean all online or electronic documentation, embedded code, programming, HTML, files, images, graphics, icons, content, and all intellectual property incorporated in or generated by KnowBC.com on the terms and conditions herein contained.
- 1.2 "End User(s)" shall mean the employees, faculty, staff, students or clients (walk-in or otherwise) officially affiliated with the Subscriber and thereby authorized to use the Service as herein licensed.
- 1.3 "Licensor" shall mean Harbour Interactive Inc., its Employees, Agents and Authorized Representatives.
- 1.4 "Site" shall mean a post-secondary institution of any one or more buildings that are a part of a single organization and serviced by one principal, administrator or similar and shall include any one or more computer workstations located within those buildings.
- 1.5 "Right to Use" shall mean the right to access, engage, view, print, and as more specifically set out in Section 4.0 herein, the limited right to copy and/or distribute the Service, during the Term.
- 1.6 "Site Administrator(s)" shall mean any administrator or other professional, of the legal age of majority, located at a Site.
- 1.7 "Subscriber" shall mean that organization or entity legally capable of, and entering into this Agreement, by way of initiating a Purchase Order for a paid subscription.
- 1.8 "Term" of this Agreement shall commence as of the start date of access to the Service and shall continue for a period of one year or less in the event that access has been terminated for cause (as outlined in Section 7.1). The Licensor will provide the Licensee with detailed terms of renewal, including fee schedules, at least ninety (90) days previous to the expiry of the Term.

1.9 Whenever referenced herein "Subscriber" and/or "Licensee" shall be interpreted to include any and all Site Administrator(s) and/or End User(s) at each subscribing Site.

2.0 Ownership

- 2.1 The software and content of KnowBC.com are the sole property of the Licensor and the copyright holders. The Licensor warrants that it either owns the copyright to materials included in the Service or else has obtained legal permission to publish all materials included from those who do control copyright therein. The Licensor will hold harmless the Licensee against all claims and losses, costs and damages that the Licensee may incur by reason of any breach or alleged breach of the foregoing warranties. No limitation of liability set forth elsewhere in this agreement is applicable to this indemnification. Permission to use any of the material other than for personal use of the licensee must be obtained in writing from the copyright holders. The Service and all trademarks, trade names, copyrights and all other intellectual property which may or may not be defined are owned by the Licensor and are protected by Canadian and US copyright laws and international treaties. No materials from the Service or any Web site owned, operated, licensed or controlled by the Licensor, may be reproduced, republished, uploaded, posted or transmitted in any way, except as specifically set out herein for non-commercial educational use only.
- 2.2 No distribution, transfer, sale, lease, or assignment of the Service in part or in whole may be made by the Licensee, to any other person, Site, subsidiary or parent organization.
- 2.3 The Subscriber may not decompile, reverse engineer, upload, post, transmit or commercially exploit the Service or any part thereof.
- 2.4 Where the rights herein to copy or distribute the Service, or any part of it, are exercised by the Subscriber, the Subscriber shall reproduce the copyright notice and any other legend of ownership on each copy, or partial copy, of the Service or document copies.
- 2.5 Notwithstanding 2.1 above, the Subscriber may incorporate parts of the Service in printed Course Packs and Electronic Reserve collections for the use of Authorized Users in the course of instruction, but not for Commercial Use. 3.0 Subscription Fees

- 4.4 The Site Administrator(s) acknowledge that the Service includes features that provide access to electronic mail and Internet sites which are not governed by the Licensor and that the access to these features and/or Internet sites is at the sole responsibility and liability of the End User.
- 4.5 The Subscriber shall use its best efforts to prevent any illegal use of the Service or Documentation by its Site Administrator(s), End User(s), agents, assigns or any other person, organizations or Sites.

5.0 Limitation of Liability

- 5.1 The Licensor assumes no responsibility for the selection of this Service to achieve any intended purposes, for the proper use of this Service and for verifying the results obtained from use of this Service. The Licensor licenses this Service "as is" and does not warrant that the functions contained in this Service will meet any requirements, that the Service is fit for any particular purpose or that the operation of the Service will be uninterrupted or error-free. The Licensor will make its best efforts to ensure 24-hour access and uninterrupted service at all times.
- 5.2 The Licensor does not warrant that the Service is compatible with every Internet browser or with every workstation.
- 5.3 Should the Service or any part of it be found defective the Licensor's liability shall be limited to the replacement of same.
- 5.4 Neither the Licensor nor the Subscriber shall be liable for any incidental, consequential or indirect damages (including but not limited to damages for loss of profits, interruption or loss of information) arising out of the use of or inability to use the Service, including if the Licensor or any authorized representative has been advised of the possibility of such damages.
- 5.5 The Licensor makes no representations or warranties, expressed or implied, nor assumes any responsibility or liability for any restriction, complication, non-compliance, suitability or non-compatibility of the technology, software or hardware used by the Subscriber to access and use the Service.

7.0 Termination of Agreement

7.1 Unless renewed by agreement between the Licensor and Licensee, this Agreement shall immediately and automatically terminate i) upon the expiry of the term of the fully paid subscription to the Service; or ii) in the event of a willful, material or persistent breach of the terms of this Agreement and a failure to remedy any such breach within thirty (30) days of written notification.

7.2 Any and all use of the Service by the Subscriber following termination of the Licence term is prohibited and may result in additional fees and charges being levied against the Subscriber.

7.3 Paragraphs 2, 4, 5, 6 and 7 shall survive the termination or expiration of this Licence.

8.0 General Provisions

8.1 The Licensor shall not be liable to the Subscriber for a discontinuation of the Service due to reasons directly attributable to the server of the Licensor provided the period of the discontinuance does not exceed 12 days, in the aggregate, during the Term. In the event this period is exceeded, the Subscriber shall be entitled to a pro-rated rebate of the subscription fee for the additional period.

8.2 The Licensor's waiver, failure or delay to exercise any right, provision or entitlement herein shall not be deemed to constitute a waiver of same or any other provision, right or entitlement herein.

8.3 This Agreement, which where applicable includes the Subscriber's Purchase Order Form, shall constitute--in combination with any provincial licensing agreement established between the Licensor and the Ministry of Education--the entire agreement between the parties and supersede all prior agreements and understandings, oral or written, express or implied, by and between any of the parties with respect to the subject matter of this Agreement.

8.4 These terms shall be governed by and construed in accordance with the laws of the Province of British Columbia.

8.5 If any one or more of the provisions contained in this Agreement should be invalid, illegal or unenforceable in any respect in any jurisdiction, the validity, legality and enforceability of such provision or provisions shall not in any way be affected or impaired as a result of such event in any other jurisdiction and the validity, legality and enforceability of the remaining provisions contained in this Agreement shall not in any way be affected or impaired as a result of such event, unless in either case as a result of such determination this Agreement would fail in its essential purpose.
